(1) <u>BodyWorks Practitioner</u>

Phyllis Emma Wolf, Diplomate in Asian Bodywork Therapy (NCCAOM) 23450, Wisconsin Licensed Massage Therapist and Bodyworker (3241-146), Wisconsin Licensed Aesthetician (2658-086).

(2) <u>Wisconsin Statutes and Administrative Code</u>

The State of Wisconsin has adopted minimum educational and training standards for licensed massage therapists and bodyworkers. The Practitioner has surpassed the required amount of classroom training to satisfy the State of Wisconsin licensing requirements under RL 91 and Ch. 460. Under Wisconsin Statutes subchapter XI 440.98, a licensed or registered massage therapist or bodyworker may not provide 1. medical diagnosis, 2. instruction or prescribe rehabilitative strengthening or conditioning exercises that are within the practice of physical therapy, as defined in s. 448.50 (4). The State of Wisconsin has adopted 600 clinical education and training standards for aesthetician licensing. The Practitioner has surpassed the required amount of classroom training through a school of aesthetics licensed under s.440.62(3)(a) and completes a minimum of 100 continuous education hours annually.

As a client, you have the right to file a complaint with BodyWorks, either in person, by phone or in writing.

(6) Fees

The studio hourly rate for services is \$100.00 per hour. Fees for specialty services are available at the website www.HealingGroundHayward.com. Services do not include tax.

BodyWorks expects payment for services at the time of client intake. In the event of client cancellation, 12-hour notice is required. Clients who either fail to cancel 12 hours in advance or who fail to arrive for their scheduled appointment will be billed the full appointment price. Lnsurance and most HMOs generally do not cover bodywork services.

(7) Notification of Service or Fee Changes

As a client, you have the right to reasonable notice of changes in service or charges. BodyWorks shall notify Clients in writing regarding fee changes at least one month prior to a change.

(11) Client Confidentiality

Your client records and transactions at BodyWorks are confidential unless the release of these records is authorized in writing by you, or otherwise provided for by law.

(12) Access to Client Records

As a client, you have the right to request access to your client records at BodyWorks. Requests must be submitted in writing to BodyWorks. Records may be reviewed by appointment. Copies will be provided within 24 hours with a minimum \$5.00 administrative fee and \$.25 per copied page.
